L'Arche celebrates the unique value of every person and recognizes the community's need for one-another. L'Arche is a French word for 'Ark' - our philosophy is one of shared humanity. Locally, the L'Arche leadership team is made up of the CEO, Assistant Program Director as well as house leaders and staff.

These activities include such things as: meal preparation, attending appointments, outings, church and recreational activities; home care, cleaning, and medication administration, physical care; and skill development. Some core member's daily activities include employment programs. Individual Service Plans exist for each core member.
